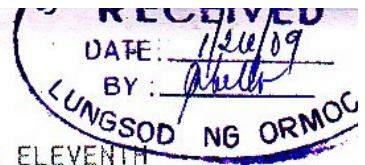

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE ENERGY DEVELOPMENT CORPORATION IN BEHALF OF THE CITY GOVERNMENT OF ORMOC FOR THE CONCRETING WORKS OF BRGY. MILAGRO - BRGY. CABINGTAN JUNCTION ROAD.

WHEREAS, this Sanggunian is in receipt of a 1st Indorsement dated January 14, 2009 from the office of the City Mayor Eric C. Codilla, requesting for authority to enter into and sign the Memorandum of Agreement (MOA) with the Energy Development Corporation (EDC) for and in behalf of the City Government of Ormoc for the concreting works of Brgy. Cabingtang Junction Road;


