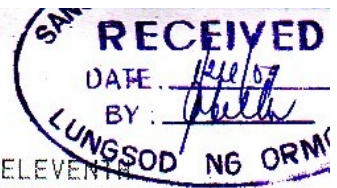

RESOLUTION NO. 2009-015

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) ON FUND TRANSFER BY AND BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE VIII AND THE LOCAL GOVERNMENT UNIT OF ORMOC CITY.

WHEREAS, this august Body is in receipt of an indorsement dated December 19, 2008 from the Honorable City Mayor Eric C. Codilla in connection with the Memorandum of Agreement (MOA) on Fund Transfer by and between the DSWD Field Office VIII and the Local Government Unit of Ormoc City and further requesting for authority to sign the same;

WHEREAS, the agreement embodies the terms and conditions set forth under which the DSWD Field Office VIII will implement the "Katas ng VAT: Tulong Para Kay Lolo and Lola Project" of Her Excellency, President Gloria Macapagal-Arroyo;

WHEREAS, the aforementioned project is a one-time cash subsidy of P500.00 for qualified senior citizens to be funded through a National Government Allocation from its oil VAT collection. It is purposely done to augment the resources of poor senior citizens and as a way of recognizing their contribution to nation building;

WHEREAS, the implementation of the said project shall be undertaken by the DSWD thru its Field Offices in coordination with the concerned LGU's and the Office of the Senior Citizens Affairs (OSCA);

WHEREAS, the Memorandum of Agreement (MOA) further provides that the DSWD Field Office VIII shall transfer funds in the amount of ONE MILLION TWENTY THREE THOUSAND FIVE HUNDRED PESOS (P1,023,500.00) to the Local Government Unit of Ormoc City to fund the above project, the distribution of the said fund to qualified beneficiaries is subject to the terms and conditions provided for in the agreement and the Implementing Guidelines for the "KATAS NG VAT - TULONG PARA KAY LOLO AT LOLA" project;

WHEREAS, this sanggunian finds the request of the Honorable City Mayor to be meritorious hence, the same necessitates due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Fe S. Lladoc, Chairman, Committee on Social Welfare, severally seconded by City Councilors Mariano Y. Corro, Ruben R. Capahi and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. 
ADOPTED, January 22, 2009.
