A RESOLUTION APPROVING ORDINANCE NO. 2008-10 OF THE
BARANGAY COUNCIL OF BARANGAY DISTRICT 26, THIS CITY,
ENTITLED: "AN ORDINANCE IMPOSING A TAX ON STORES, OR
RETAILERS WITH A FIXED BUSINESS ESTABLISHMENT,
OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR
SIGNS, SIGNBOARDS, AND BILLBOARDS".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
2008-10 of the Barangay Council of Barangay District 26, entitled: "AN
ORDINANCE IMPOSING A TAX ON STORES, OR RETAILERS WITH A FIXED BUSINESS
ESTABLISHMENT, OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR SIGNS,




