

RESOLUTION NO. 2009-030

A RESOLUTION APPROVING ORDINANCE NO. 2008 - 06 OF THE BARANGAY COUNCIL OF BARANGAY PATAG, THIS CITY, ENTITLED: "AN ORDINANCE FIXING THE RATES OF THE BARANGAY CLEARANCE FEES, PERMITS, AND OTHER CHARGES AND FEES FOR THE AVAILMENT OF USE OF VARIOUS PROPERTIES AND SERVICES OF THE BARANGAY".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance 2008-06 of the Barangay Council of Barangay Patag, entitled: ORDINANCE FIXING THE RATES OF THE BARANGAY CLEARANCE FEES, PERMITS, OTHER CHARGES AND FEES FOR THE AVAILMENT OF USE OF VARIOUS PROPERTIES AND SERVICES OF THE BARANGAY":

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to aforecited ordinance at issue and all other ordinances of the Sangguniang Barangay in Ormoc City, is by law, granted the Power to review as to whether said ordinance is consistent with law and city x - xx ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the said ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Patag to legislate;
