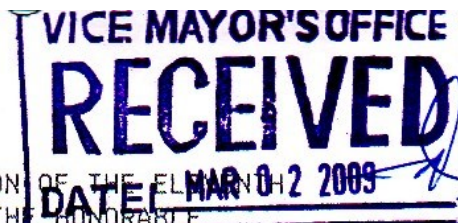

RESOLUTION NO. 2009-036

A RESOLUTION INTERPOSING NO OBJECTION TO THE PROPOSED MOUNTAIN QUARRY PROJECT OF MR. DEXTER PEPITO LOCATED AT BARANGAY SAN VICENTE, ORMOC CITY, BASED ON RESOLUTION NO. 21, SERIES OF 2008 OF THE BARANGAY COUNCIL OF SAN VICENTE INTERPOSING NO OBJECTION TO THE SAID PROJECT.

WHEREAS, this Sanggunian is in receipt of a request from Mr. Dexter Pepito for a mountain quarry permit, the same is supported by a Barangay Resolution of San Vicente Interposing no objection to the same;

WHEREAS, this item was referred to the Office of Engr. Juliana P. Flores, Supervising Environmental Management Specialist, and returned with the observation and recommendation that quarrying in the area is possible and that there are no residential houses in the surroundings;

WHEREAS, the applicant, Mr. Dexter Pepito is also applying for an Environmental Compliance Certificate (ECC) and issuance of these conditionalities is needed prior to his operation;

WHEREAS, this approval is subject to the final issuance of the said ECC;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Claudio P. Larrazabal, Vice-Chairman, Committee on Natural Resources and Environmental Control, duly seconded by City Councilor Mariano Y. Corro; be it



ADOPTED, February 26, 2009.


