A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT BY AND AMONG THE LOCAL GOVERNMENT ACADEMY (LGA) OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), THE CITY GOVERNMENT OF ORMOC AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT -VILL FOR THE PREPARATION AND IMPLEMENTATION OF THE HUMAN RESOURCE MANAGEMENT DEVELOPMENT (HRMD) PLAN OF THE CITY OF ORMOC

WHEREAS, this sanggunian is in receipt of an urgent indorsement dated February 25, 2009 from the Office of the City Mayor requesting that the Honorable City Mayor be granted authority to sign the Memorandum of Agreement (MOA) by and among the Local Government Academy (LGA) of the Department of the Interior and Local Government, the City Government of Opmoc and the Department of the Interior and Local Government - Region VIII;
