RESOLUTION NO. 2009-040

A RESOLUTION REQUESTING SUPPLIERS/ DISTRIBUTORS OF PETROLEUM PRODUCTS IN ORMOC CITY TO REDUCE THEIR SELLING PRICE OF PETROLEUM PRODUCTS IN ORMOC CITY CONSIDERING THAT THE SELLING PRICE OF THE SAME IN OTHER PARTS OF THE COUNTRY, PARTICULARLY, IN DAVAO CITY, NUEVA ECIIJA AND METRO MANILA IS VERY MUCH LOWER THAN IN ORMOC CITY.

WHEREAS, it is a public knowledge that prices of petroleum products today have considerably gone down especially that of diesel fuel;

WHEREAS, the implementation of the roll-backs of the prices of oil products in Ormoc City have been closely monitored by the people themselves and the city officials as well;

WHEREAS, just recently there are reports that prices of petroleum products in Ormoc City, especially gasoline and diesel, are much higher compared to that of other key cities and provinces in our country like Metro Manila, Davao and Nueva Ecija;

WHEREAS, in view of such reports the Honorable City Mayor initiated measures to confirm the veracity of the same. And indeed, such reports were confirmed that the prices of oil products in Ormoc City, particularly diesel and gasoline, are much higher compared to the aforementioned places;

WHEREAS, in order to safeguard the interest and welfare of the people, this sanggunian deems it appropriate to communicate and reach-out to the suppliers/ distributors of petroleum products in our city so that fairness and uniformity of prices can be obtained;



WHEREFORE, FOREGOING PREMISES CONSIDERED, on mass motion of the Body;

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution REQUESTING SUPPLIERS/ DISTRIBUTORS OF PETROLEUM PRODUCTS IN ORMOC CITY TO REDUCE THEIR SELLING PRICE OF PETROLEUM PRODUCTS IN ORMOC CITY CONSIDERING THAT THE SELLING PRICE OF THE SAME IN OTHER PARTS OF THE COUNTRY, PARTICULARLY, IN DAYAO CITY, NUEVA ECIJA AND METRO MANILA IS VERY MUCH LOWER THAN IN ORMOC CITY.


