A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE ENERGY DEVELOPMENT CORPORATION (EDC) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this Sanggunian is in receipt of a 1st Indorsement dated February 25, 2009 from the office of the City Mayor Eric C. Codilla requesting for authority to enter into and sign the Memorandum of Agreement (MOA) with the Energy Development Corporation (EDC) for and in behalf of the City Government of Ormoc;

WHEREAS, the said Memorandum of Agreement refers to the maintenance of the Bao River bed as part of the Bao River Mitigation Project to ensure that the same will not overflow and cause destruction to structures installed by EDC and the City Government of Ormoc;

WHEREAS, this august Body believes that said request is beneficial to a greater number of constituents, hence the same must be given the necessary course of action;


