A RESOLUTION AUTHORIXING THE CITY TREASURER ANGELO I. ROMAN TO DEPOSIT UNDER HIGH YIELD SAVINGS ACCOUNT AT DEVELOPMENT BANK OF THE PHILIPPINES, ORMOC BRANCH THE ANOUNT OF FIVE MILLION THREE HUNDRED NINETEEN THOUSAND FOUR HUNDRED FORTY FOUR PESOS & 44/100 (\$5,319,444.44).

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated Pebruary 24, 2009 from the Office of the Honorable City Mayor Eric C. Sanggunian is in receipt of 1st Indorsement dated Codilla requesting the letter-request of Mr. Angelo I. Roman, to authorize the City Treasurer to deposit under High Yield Savings Account Development Bank of the Philippines the amount of P5,319,444.44 epresenting the sum returned by PCI Equitable Bank;

WHEREAS, said letter further states that the Development Bank of the Philippines, Ormoc Branch offered an interest rate of three and one half percent (3.5%) which is higher compared to other banks;

WHEREAS, this august Body believes that said request is reasonable. hence the same be accorded due course of action;
