RESOLUTION NO. 2009-051

A RESOLUTION APPROVING ORDINANCE NO. 2008 - 06 OF THE BARANGAY COUNCIL OF BARANGAY DOÑA FELIZA MEJIA, THIS CITY, ENTITLED: "AN ORDINANCE PROHIBITING THE SOLAR DRYING OF PALAY AT THE BASKETBALL COURT AND THE MULTI-PURPOSE PAVEMENT AT PUROK VI, BARANGAY DOÑA FELIZA MEJIA, ORMOC CITY".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance NO. 2008-06 of the Barangay Council of Barangay Doña Feliza Mejia, entitled: "AN ORDINANCE PROHIBITING THE SOLAR DRYING OF PALAY AT THE BASKETBALL COURT AND THE MULTI-PURPOSE PAVEMENT AT PUROK VI, BARANGAY DOÑA FELIZA MEJIA, ORMOC CITY";


