RESOLUTION NO. 2009-052

A RESOLUTION APPROVING ORDINANCE NO. 2009 - 02 OF THE BARANGAY COUNCIL OF BARANGAY MARGEN, THIS CITY, ENTITLED: "AN ORDINANCE IMPOSING A TAX ON STORES, OR RETAILERS WITH A FIXED BUSINESS ESTABLISHMENT, OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR SIGNS, SIGNBOARDS, AND BILLBOARDS, AND FEES ON CLEARANCES AND CERTIFICATIONS ISSUED BY THE BARANGAY TO ANY PERSON".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance NO. 2009-02 of the Barangay Council of Barangay Margen, entitled: "AN ORDINANCE IMPOSING A TAX ON STORES, OR RETAILERS WITH A FIXED BUSINESS ESTABLISHMENT, OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR SIGNS, SIGNBOARDS, AND BILLBOARDS, AND FEES ON CLEARANCES AND CERTIFICATIONS ISSUED BY THE BARANGAY TO ANY PERSON";
