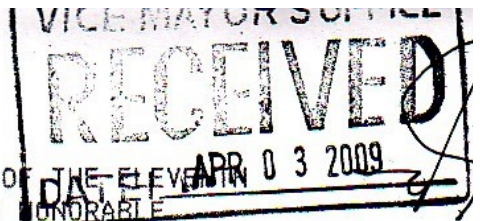

RESOLUTION NO. 2009-061

A RESOLUTION APPROVING ORDINANCE NO. 2009 - 01 OF THE
BARANGAY COUNCIL OF BARANGAY LIBERTAD, THIS CITY,
ENTITLED: "AN ORDINANCE IMPOSING A TAX ON STORES OR
RETAILERS WITH A FIXED BUSINESS ESTABLISHMENT OPERATING
WITHIN THIS BARANGAY".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
2009 - 01 of the Barangay Council of Barangay Libertad, entitled: "AN
ORDINANCE IMPOSING A TAX ON STORES OR RETAILERS WITH A FIXED BUSINESS
ESTABLISHMENT OPERATING WITHIN THIS BARANGAY";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the

Ordinances, duly seconded by City Councilor Claudio P. Larrazabal; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING
