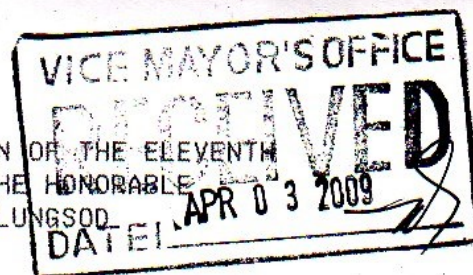

A RESOLUTION APPROVING ORDINANCE NO. 2009 - 03 OF THE  
BARANGAY COUNCIL OF BARANGAY LIBERTAD, THIS CITY,  
ENTITLED: "AN ORDINANCE IMPOSING FEES ON CLEARANCES AND  
CERTIFICATIONS ISSUED BY THE BARANGAY TO ANY PERSON".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance NO.  
2009-03 of the Barangay Council of Barangay Libertad, entitled: "AN  
ORDINANCE IMPOSING FEES ON CLEARANCES AND CERTIFICATIONS ISSUED BY THE  
BARANGAY TO ANY PERSON";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited ordinance at issue and all other ordinances of the


RESOLVED, FURTHER, to furnish copies of this resolution each to His
