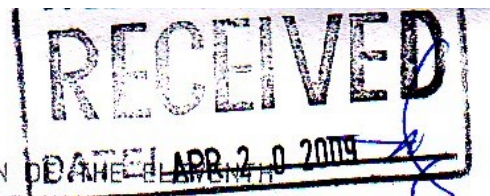

ADOPTED, APRIL 16, 2009.


