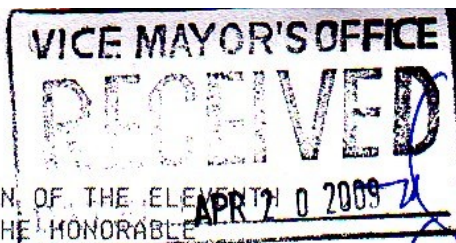

BUHAYIN, HANGIN LINISIN, BATAS TUPARIN", TOGETHER WITH THE WHOLE NATION;


