A RESOLUTION TO CHANGE THE NAME "HOLDING CENTER" OF THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE (CSWDO) TO "SOCIAL DEVELOPMENT CENTER FOR CHILDREN AND YOUTH" UNDER SAME OFFICE.

this august Body is in receipt of an indorsement dated April 13, 2009 from the Office of the City Mayor relative to the letterrequest of Mrs. Marietta 3. Legaspi, City Social Welfare and Development Officer, this city, for the passage of a resolution re: changing the name "HOLDING CENTER" of the CSWDO to "SOCIAL DEVELOPMENT CENTER FOR CHILDREN AND YOUTH;

WHEREAS, the Holding Center is a facility run and managed by the CSWDO in connection with the Child and Youth Welfare Program of same office. It serves as a temporary shelter to male children in conflict with law, like hardcore rugby boys and other juvenile delinquent children/youths, and street children whose ages are from seven (7) years old and below eighteen (18) years old;

WHEREAS, the Center provides 24-hour residential services to the aforementioned children-residents and likewise attends to their basic needs including that of their education;

WHEREAS, in view of the implementation of R.A. 9344, otherwise as the "Juvenile Justice and Welfare Act of 2006" the services/activities of the Holding Center has been intensified. Under the said law, children below eighteen (18) years of age at the time of commission of the offense shall be exempt from criminal liability, however, they shall be subjected to an intervention program and if necessary shall be placed in an institution under the DSWD/CSWDO for rehabilitation. As an effect thereof, the services catered by the Center has been broadened to properly respond to the said provision of the law;
