RESOLUTION NO. 2009-080

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION
OF PLDT GROUP TO INSTALL A 3-LEGGED TELECOMMUNICATION
TOWER AT BARANGAY BANTIGUE, THIS CITY.

WHEREAS, this august Body is in receipt of a communication dated January 26, 2009 from the PLDT Group represented by Engr. Vladimir G. Pascual, requesting for a resolution interposing no objection to their proposed improvement project at Brgy. Bantigue, this city, which is the installation of a 3-Legged Telecommunication Tower in said barangay;

WHEREAS, the Sangguniang Barangay of Bantigue has manifested their support to the said project as contained in their Resolution No. 02, Series of 2009, entitled: "A RESOLUTION INTERPOSING NO OBJECTION TO THE INSTALLATION OF A MACRO CELLULAR/OUTDOOR SITE OF PLDT GROUP IN BARANGAY BANTIGUE, ORMOC CITY, LEYTE;

WHEREAS, in a Public Consultation conducted last December 18, 2008, the Home Owners of Barangay Bantigue has expressed their support and conformity to the said project;

WHEREAS, the installation of a cell site tower in Brgy. Bantigue is deemed beneficial to the people considering that it will result to a better signal coverage in the neighboring places and will help boost the development of the city;

WHEREAS, it is presumed by this sanggunian that the subject cell site tower and accessories to be constructed and installed by PLDT Group is in conformity with the specifications provided and required by the National Telecommunications Commission;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Communication & Transportation, jointly seconded by City Councilors Ruben R. Capahi and Sotero M. Pepito; be it
