RESOLUTION NO. 2009-083

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD UNIT NO. 8 (DA-RFU 8) AND THE NATIONAL IRRIGATION ADMINISTRATION (NIA).

WHEREAS, this august Body is in receipt of an indorsement dated March 27, 2009 from the Honorable City Mayor Eric C. Codilla relative to the Memorandum of Agreement by and among the Department of Agriculture - Regional Field Unit No. 8, the National Irrigation Administration (NIA) and the LGU of Ormoc City. In same indorsement the Honorable City Mayor further requested for authority to sign the said Agreement;

WHEREAS, the focus of the Memorandum of Agreement is the First Phase or initial establishment of the Hybrid Rice Ratooning Project in Ormoc City;

WHEREAS, the Rice Ratooning Project is in line with the GMA Rice Program of the Department of Agriculture which promotes the use of hybrid rice varieties to boost local rice production. It was proven to be one of the potential and attractive alternative technologies that will enhance rice production, hence, the City of Ormoc has adopted the hybrid rice technology as one of its Food Security Projects;

WHEREAS, the agreement further provides that during the first year of implementation of the Rice Ratooning Project, the DA-RFU 8 shall transfer a total amount of Six Hundred Twenty Five Thousand Pesos (P625,000.00) to the Local Government Unit of Ormoc City for the procurement and distribution of UREA Fertilizers (46-0-0) to farmer-beneficiaries at the rate of one (1) bag per hectare;



WHEREAS, the Rice Ratooning Technology requires enough supply of irrigation water to maximize yield and in such case, the National Irrigation Administration (NIA) through the Bao River Irrigation System (RIS) will take charge of providing sufficient irrigation water for the said project;

WHEREAS, the Rice Ratooning Project is deemed beneficial to the people;

WHEREAS, this sanggunian finds the provisions of the Memorandum of Agreement to be in order, hence, the request of the Honorable City Mayor to sign the same necessitates due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture, jointly seconded by City Councilors Rafael C. Omega, Jr. and Jose C. Alfaro, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD UNIT NO. 8 (DA-RFU 8) AND THE NATIONAL IRRIGATION ADMINISTRATION (NIA);

RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to this sanggunian for information and file;


