

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
2009-002 of the Barangay Council of Barangay Tongonan, entitled: "AN
ORDINANCE CREATING THE FOLLOWING POSITIONS AT THE SANGGUNIANG BARANGAY
