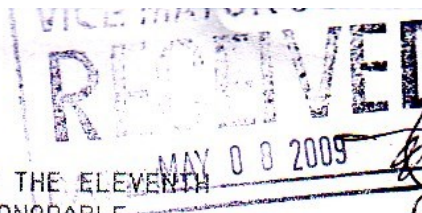

RESOLUTION NO. 2009-095

A RESOLUTION STRONGLY URGING GSIS CEO, HONORABLE WINSTON
F. GARCIA TO RESTORE THE ORIGINAL SCHEDULE IN THE
PAYMENT OF PENSIONS TO THE GSIS PENSIONERS.

WHEREAS, GSIS pensioners very recently received a text message from
GSIS as follows:

"Pls b advised that starting May 2009, ur monthly pension will
b credited to ur eCard account every 8th day of the month. Pls b
guided accordingly. Inx"

WHEREAS, GSIS pensioners used to receive their monthly pensions on
the 1st or 2nd day of the applicable month;

WHEREAS, the sudden change of schedule of payment of their monthly
pension, SANS consultation with the pensioners, is clearly prejudicial,
and inhuman to them; that instead of being able to make use of their
monthly pension on the first day of the month, they now have to wait for
another week before they could avail of their meager pension; hence,
GSIS management should consider these adverse effects in the change of
the payment schedule;

WHEREAS, the present economic crisis should have been considered by
the GSIS management in making the said change since this affects the
paying capacity of the GSIS pensioners who are entirely dependent on
their pensions;

WHEREAS, it is our hope and prayer that GSIS management comes to
their good senses and realize the unfairness and injustice brought about
by the change in the payment schedule of their pensioners;

FOREGOING, PREMISES CONSIDERED, on MASS MOTION of the Body; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution STRONGLY URGING GSIS CEO, HONORABLE WINSTON F. GARCIA TO RESTORE THE ORIGINAL SCHEDULE IN THE PAYMENT OF PENSIONS TO THE GSIS PENSIONERS;
