RESOLUTION NO. 2009-096

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE UNPAID NEWSPAPER SUBSCRIPTION FOR THE LAST QUARTER OF CY 2008 OF THE CITY ASSESSOR'S OFFICE IN THE AMOUNT OF ONE THOUSAND FOUR HUNDRED FIFTY PESOS (P1,450.00) AGAINST THE CURRENT APPROPRIATION FOR OFFICE SUPPLIES EXPENSE OF THE SAME OFFICE.

WHEREAS, this august Body received an indorsement dated April 28, 2009 from the Office of the City Mayor relative to the request of Mrs. Erlinda A. Solana, City Assessor, for authority to charge against the current appropriation for Office Supplies Expense the unpaid newspaper subscription for the last quarter of CY 2008 of her office in the amount of One Thousand Four Hundred Fifty Pesos (P1,450.00);

WHEREAS, in the same indorsement the Office of the City Mayor further requested this Sanggunian for the passage of a resolution authorizing the City Accountant to charge the aforementioned obligation against the current appropriation for Office Supplies Expense of the City Assessor's Office;

WHEREAS, the matter was referred to both the Offices of the City Budget Officer and the City Treasurer, respectively, for comment and recommendation and for certification as to the availability of funds;

WHEREAS, in turn the City Budget Officer, through an indorsement dated May 5, 2009 has reiterated that the City Accountant be granted authority to charge the said unpaid newspaper subscription of the City Assessor's Office against the current appropriation for Office Supplies Expense of same office;

WHEREAS, the City Treasurer, through another indorsement, dated May 5, 2009 has informed this Body that funds are available to cover the said obligation under the current appropriation for Office Supplies Expense of the City Assessors Office;
