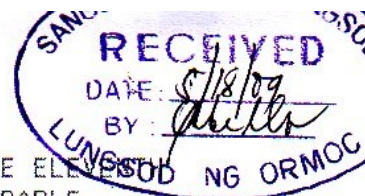

A RESOLUTION APPROVING THE APPLICATION FOR PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE (PALC) UNDER BP 220 OF OCEAN VIEW URBAN POOR HOMEOWNER'S ASS'N. INC. COMPRISING LOT NO. 1631-B-1, PSD-08-023532-D COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 51198 LOCATED AT BARANGAY ALTA VISTA, ORMOC CITY WITH A NET PROJECT AREA OF TWENTY ONE THOUSAND TWENTY (21,020) SQUARE METERS MORE OR LESS, OWNED BY ROY BERNARD FIEL, ET AL., CONTAINING 171 SALEABLE LOTS EXCLUDING ROAD LOTS, COMMUNITY FACILITIES, AND PARKS AND PLAYGROUND.

WHEREAS, this Sanggunian has received an application for Preliminary Approval and Locational Clearance (PALC) under BP 220 of Ocean View Urban Poor Homeowner's Ass'n. Inc. comprising Lot No. 1631-B-1, Psd-08-023532-D covered by Transfer Certificate of Title No. 51198 located at Brgy. Alta Vista, Ormoc City with a net project area of TWENTY ONE THOUSAND TWENTY (21,020) square meters more or less, owned by Roy Bernard Fiel Et. Al., containing 171 saleable lots excluding road lots, community facilities, and parks and playground;

WHEREAS, the City Planning & Development Coordinator, in a communication dated March 27, 2009, stated that their office finds the aforementioned subdivision project to be in accordance with the provisions of BP 220, EO 648 and its Implementing Rules and Regulations and further recommended to this august Body for the granting of Preliminary Approval and Locational Clearance (PALC) to the said subdivision project;
