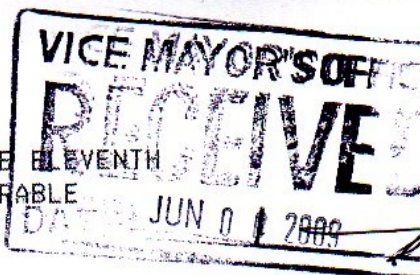

ADOPTED, May 28, 2009.


