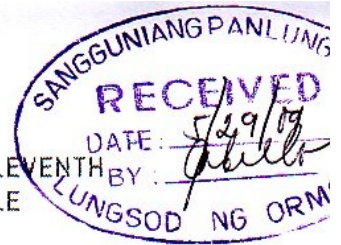

RESOLUTION NO. 2009-107

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF AGRICULTURE, REGION 8 FOR THE PROCUREMENT OF ONE (1) UNIT WELL VENTILATED VAN THROUGH COUNTERPARTING SCHEME TO THE LOCAL GOVERNMENT UNIT OF ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of a letter dated June 13, 2008 from the Office of the City Mayor requesting for the passage of a resolution authorizing him to enter into and sign a Memorandum of Agreement (MOA) in behalf of the City Government of Ormoc with the Department of Agriculture, Region 8 for the procurement of one (1) unit well ventilated van through counterparting scheme to the Local Government of Ormoc City;

WHEREAS, the said Memorandum of Agreement (MOA) refers to the unification of above parties for the purpose of modernizing farming activities from pre-production to post-production, which contribute to the development of the vegetable industry of the City of Ormoc;

WHEREAS, believing that said request is beneficial to the farmers-beneficiaries in the City, the same must be given the necessary course of action;
