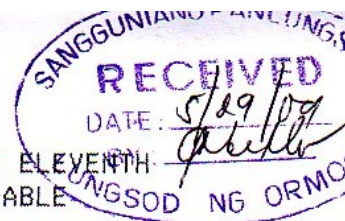

RESOLUTION NO. 2009-108

A RESOLUTION ADOPTING THE BAGSAKAN CENTER (BC) PROJECT OF THE DEPARTMENT OF AGRICULTURE AND AUTHORIZING THE LOCAL CHIEF EXECUTIVE, ERIC C. CODILLA FOR AND IN BEHALF OF THE CITY TO SIGN MOA/DOCUMENTS AND TRANSACT BUSINESS WITH THE DEPARTMENT OF AGRICULTURE RELATIVE TO THE IMPLEMENTATION OF BAGSAKAN CENTER (BC) PROJECT.

WHEREAS, the Department of Agriculture (DA) is Implementing Goal 2 Program specifically addressing major concerns on food security, poverty alleviation and social equity, income enhancement and profitability of farmers and global competitiveness and sustainability by providing sufficient, quality and low-priced wage goods;

WHEREAS, one of the programs for which the DA-RFU 8 is implementing the Bagsakan Center (BC) Project under the Accelerated Hunger Mitigation Program which involves the direct marketing of agriculture and fishery products from the farm to the market and ensure a steady and affordable supply of food commodities in the market through improvements of the market structure such as the provision of equipment, other facilities and capital;

WHEREAS, the City of Ormoc was selected by the DA as one of the pilot city to implement the Bagsakan Center Project;

WHEREAS, the local government unit considers the Bagsakan Center (BC) Project as a means of achieving the goals of this program and therefore desires to participate in its implementation;

WHEREAS, the City Council of Ormoc manifest its interest to participate in the implementation of the Bagsakan Center Project and abide by its framework and objectives;

WHEREAS, Section 444 (b) (1) (iv), Chapter 1, Title Two, Book III of the Republic Act 7160 otherwise known as the "Local Government Code of 1991" provides that, "The City Mayor, as the local chief executive of the city government.... shall, upon authorization by the Sangguniang Panlungsod, represent the city in all its business transactions and sign on its behalf all bonds, contracts, and obligations and such other documents made pursuant to law or ordinance";

NOW THEREFORE, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture, severally seconded by City Councilors Claudio P. Larrazabal, Fernando P. Parrilla and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to adopt the Bagsakan Center (BC) Project and authorize the Local Chief Executive ERIC C. CODILLA to sign MOA/documents and transact with the Department of Agriculture relative to the implementation of the Bagsakan Center (BC) Project and to ratify the Terms and Conditions of the documents;


ADOPTED, May 28, 2009.


