RESOLUTION NO. 2009-113

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF UNDERSTANDING (MOU) BY AND AMONG THE PHILIPPINE BAND OF MERCY (PBM), ST. STEPHEN'S MISSION OUTREACH (SSMO), FOURTH CONGRESSIONAL DISTRICT OF LEYTE, CITY GOVERNMENT OF ORMOC, AND ORMOC DISTRICT HOSPITAL.

WHEREAS, this sanggunian has received an indorsement dated May 14, 2009 from the Honorable City Mayor Eric C. Codilla requesting for authority to enter into and sign the Memorandum of Understanding (MOU) by and among the Philippine Band of Mercy (PBM), St. Stephen's Mission Outreach (SSMO), Fourth Congressional District of Leyte, City Government of Ormoc and Ormoc District Hospital;

WHEREAS, the agreement refers to the involvement and coordination of the above parties in the conduct of a Cleft Surgical Mission in Ormoc City on June 10-12, 2009;

WHEREAS, the undertaking is geared towards providing treatment and rehabilitation to qualified indigent patients with disabilities and deformities on cleft lip/palate;

WHEREAS, the said medical mission is a way of reaching out to the less-fortunate and indigent patients by giving them opportunity to avail of free cleft lip/palate;

WHEREAS, this august Body believes that the Memorandum of Understanding is beneficial to the people hence, the requested authority of the Honorable City Mayor to sign the same necessitates due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Health, jointly seconded by City Councilors Mariano Y. Corro and Fernando P. Parrilla; be it
