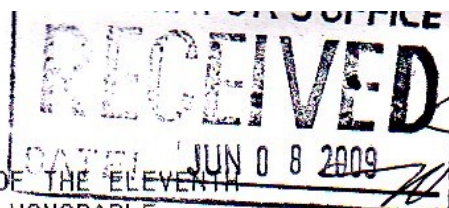

RESOLUTION NO. 2009-117

A RESOLUTION AUTHORIZING CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) AND ALLOCATING THE AMOUNT OF FOUR HUNDRED THIRTY THREE THOUSAND PESOS (P433,000.00), WHICH COMPRISED THE EQUIVALENT AMOUNT OF FORTY PERCENT (40%) AS COUNTERPART SHARE IN THE PROCUREMENT OF ONE (1) AMBULANCE UNIT, PAYMENT FOR THE THREE-YEAR LTO VEHICLE REGISTRATION AND THREE-YEAR GSIS COMPREHENSIVE INSURANCE.

WHEREAS, this august Body is in receipt of an urgent indorsement dated June 4, 2009 from the Office of the City Mayor in connection with the Memorandum of Agreement by and between the League of Cities of the Philippines and the City Government of Ormoc for the PCSO - LGU Ambulance Procurement Program;

WHEREAS, the PCSO under the Office of the President was created principally to raise funds through the lottery games to support the various healthcare programs, social, and basic services of the government aimed at uplifting the quality of life of the Filipino people;

WHEREAS, the administration of President Gloria Macapagal-Arroyo (PGMA) through the PCSO, have been in the forefront of providing healthcare programs and social services, among others to millions of Filipinos nationwide;

WHEREAS, the PCSO consistent and pursuant to Board Resolution No. 768 dated October 13, 2008, has approved the 60-40 cost sharing scheme in the procurement of ambulance unit to all the LGU member of ULAP, subject to availability of funds and applicable accounting and auditing rules and regulations;



WHEREAS, the League of Cities of the Philippines, through its National President, MAYOR BENJAMIN C. ABALOS, JR. has lobbied and endorsed the cost-sharing scheme projects between PCSO and its member cities for the acquisition of service ambulance for its constituents;

NOW, THEREFORE, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Health, jointly seconded by City Councilors Fernando P. Parrilla and Demosthenes F. Tugonon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, THAT THE SANGGUNIANG PANLUNGSOD OF ORMOC DO HEREBY AUTHORIZED CITY MAYOR ERIC C. C. CODILLA TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) IN THE COST SHARING AGREEMENT OF THE PROCUREMENT OF ONE (1) AMBULANCE UNIT AND CONCURRING THE TERMS AND CONDITIONS STIPULATED IN THE SAID MOA;


RESOLVED, FURTHER, that the City allocates the amount of FOUR HUNDRED THIRTY THREE THOUSAND PESOS (P433,000.00) representing the equivalent amount of forty percent (40%) as counterpart share of the city in the procurement of the ambulance unit, payment for the Three (3) Year LTO Vehicle Registration, and Three (3) Year GSIS Comprehensive Insurance of the City of Ormoc in the procurement of one (1) ambulance unit;

ENACTED, June 05, 2009.
