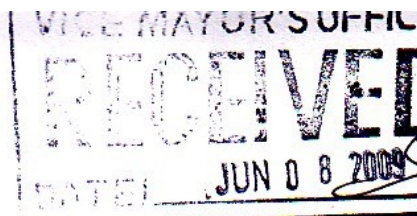

RESOLUTION NO. 2009-118

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH GERMAN TECHNICAL COOPERATION AND EUROPEAN COMMISSION HUMANITARIAN DEPARTMENT DISASTER PREPAREDNESS PROGRAM HEREIN REFERRED TO AS GTZ-DIPECHO.

WHEREAS, this Sanggunian has received an indorsement dated June 4, 2009 from the Office of the City Mayor relative to the Memorandum of Agreement by and between the City Government of Ormoc and GTZ-DIPECHO and further requesting for authority to sign the same;

WHEREAS, the subject of the agreement is the rehabilitation of a flood mitigation dike at Matica-a river along the sides of Barangay Matica-a, this city;

WHEREAS, the project is in line with the goal of the city, as mandated under PD 1566, to strengthen its disaster control capability by establishing a program on community disaster preparedness through the City Disaster Coordinating Council;

WHEREAS, GTZ-DIPECHO aims to assist the Local Government of Ormoc in its efforts of providing effective services in Disaster Risk Management particularly in barangays identified as highly vulnerable to flooding and erosion;

WHEREAS, Barangay Matica-a has been identified as one of the twenty two (22) highly vulnerable barangays in the city which is in imminent danger of being enundated considering that its flood mitigation dike has been damaged by the recent flooding and therefore needs immediate rehabilitation;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Ruben R. Capahi, Vice-Chairman, Committee on Public Safety, jointly seconded by City Councilors Mariano Y. Corro and Sotero M. Pepito; be it


