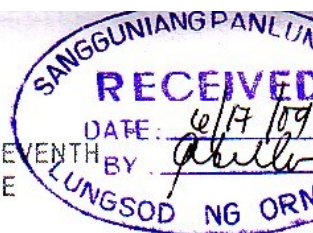

RESOLUTION NO. 2009-122

A RESOLUTION APPEALING TO THE MANAGEMENT OF GSIS TO
RECONSIDER THE CHANGE IN THE SCHEDULE OF THE CREDITING
OF MONTHLY PENSION WHICH HAVE CAUSED UNTOLD MISERIES
AMONG ITS PENSIONERS.

WHEREAS, this Sanggunian is in receipt of the letter dated May 29, 2009 from GSIS Vice President Nora M. Saludares, which letter was in reply to this Sanggunian Resolution No. 2009-059, urging GSIS to restore the original schedule in the payment of pensions to the GSIS pensioners;

WHEREAS, subject letter explained the change on pension payments, in this manner, to wit: "Since May 2009, the crediting of monthly pension is now on the 8th day of the month, to ensure that pensioners who have renewed their status (active status), as well as those who were previously suspended but later reactivated will receive their pension on the same schedule as our regular active pensioners.";

WHEREAS, the reason given for the change in the schedule of pension payment is to accommodate pensioners who have renewed their status (active status), as well as those who were previously suspended but later reactivated;

WHEREAS, to accommodate those kind of pensioners who are remiss, negligent, or not law-abiding in the performance of their duties and obligations as such pensioners of the GSIS, the Regular Active Pensioners will have to be sacrificed, in the sense that they will have to receive their monthly pensions a week later than the usual date of receipt; so the question is, is this recent policy on pension payments of GSIS, FAIR, JUST AND EQUITABLE to the Regular Active Pensioners?;

WHEREAS, it is believed/ presumed that those pensioners who have renewed their active status as well as those who were previously suspended constitute a MINORITY, when compared to the Regular Active Pensioners, hence, the recent policy of GSIS on pension payments is not for the GOOD of the greater number of its pensioners, for if it were so, then the good of the Regular Active Pensioners will be upheld rather than the minority pensioners who are on an INACTIVE status and those who were previously SUSPENDED;

WHEREAS, many Regular and Active pensioners in Ormoc City are complaining of the unwarranted, unjust and unfair policy of GSIS in changing the schedule in the payment of their monthly pensions.

WHEREAS, it is most respectfully prayed to the management of GSIS to restore the previously/ original schedule in the payment of pensions, if GSIS wants the Praise, Gratitude and Thanks of its thousand pensioners, otherwise, it will only reap the condemnation and disgust of its REGULAR ACTIVE PENSIONERS;

FOREGOING PREMISES CONSIDERED, on MASS MOTION OF THE BODY; be it




