A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF EDUCATION FOR THE CONSTRUCTION OF DEPED DIVISION OFFICE.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated June 4, 2009 from the Office of the City Mayor requesting for the passage of a resolution authorizing him to enter into and sign a Memorandum of Agreement (MOA) with the Department of Education for the construction of DepEd, Division Office;

WHEREAS, the said Memorandum of Agreement mentions a separate budget for the school building program specially for the "Construction of DepEd, Division Office" since they are just occupying a temporary building owned by the City Central School, Ormoc City;

WHEREAS, the Local Government Unit commits itself to provide the technical assistance and other support to the said project;

WHEREAS, the implementation of the Memorandum of Agreement is subject to the submission of the Program of Work;

WHEREAS, this august Body believes that said request is reasonable, hence, the same be accorded due course of action;




