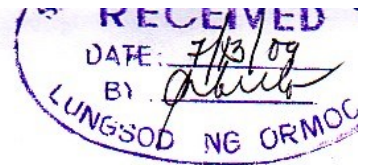

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF EDUCATION FOR THE CONSTRUCTION OF LIBRARY HUB.

WHEREAS, this Sanggunian is in receipt of Memorandum of Agreement (MOA) by and between the City Government of Ormoc with the Department of Education for the construction of Library Hub;

WHEREAS, the said Memorandum of Agreement mentions a separate budget for the school building program specifically for the "Construction of Library Hub", since DepEd, Ormoc City Division has no Library Hub;

WHEREAS, the local government unit commits itself to provide the technical assistance and other support to the said project;
