WHEREAS, this august Body is in receipt of an indorsement dated July 15, 2009 from the Office of the City Mayor relative to the Memorandum of Agreement (MOA) by and between the City Government of Ormoc and Land Bank of the Philippines;

WHEREAS, the agreement refers to the new or amended scheme of Livelihood Loan Facility offered by Land Bank of the Philippines to the city officials and employees of the Local Government Unit of Ormoc City;
