WHEREAS, the Ramon Magsaysay award is an award recognition equal only in prestige and honor to the Nobel Prize and is the highest form of award given to Asians;

WHEREAS, Attorney Antonio Asuncion Oposa Jr. was given this award for his advocay and activism, and for "His pathbreaking and passionate crusade to engage Filipinos in acts of enlightened citizenship that maximize the power of law to protect and nurture the environment for themselves, their children and generations still to come" (PhiStar Aug. 4, 2009;

WHEREAS, Atty. Antonio Oposa Jr. has his roots in Ormoc City, his father, Dr. Antonio Codilla Oposa Sr., an internationally known surgeon, hails from Cebu and Ormoc City; the father of Dr. Oposa was from Bantayan while the mother is a true-blooded Ormocanons belonging to the Codilla clan;

WHEREAS, in this year's awardees, Atty. Oposa Jr. is the only Filipino recipient, the thirty-second Filipino to receive this award and so far the only person whose roots is from Region 8 to receive this award;
