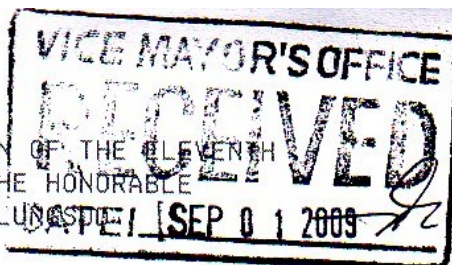

RESOLUTION NO. 2009-165

A RESOLUTION REQUESTING THE CITY DIRECTOR, PHILIPPINE NATIONAL POLICE, (PNP), THE CITY JAIL WARDEN, BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP), THE CITY FIRE MARSHAL, BUREAU OF FIRE PROTECTION (BFP), AND OTHER NATIONAL OFFICES CONCERNED, TO INCLUDE IN THE SIGNATORIES OF THEIR RESPECTIVE RETIREMENT CLEARANCES, THE CITY GENERAL SERVICES OFFICER OF ORMOC CITY, AS ONE OF THE SIGNATORIES THERETO FOR THE REASON STATED HEREIN

WHEREAS, the Eleventh Sangguniang Panlungsod ng Ormoc has received information that a number of equipments and properties of the city has been issued to personnel of some national offices in line with their official duties and functions. Such information was confirmed by the City General Services Officer, Engr.Domardoni C. Cayanong, henceforth, a complete List of Properties was furnished to the Legislative council a regards thereto;

WHEREAS, the City General Services Officer, through a communication dated August 4, 2009, has expressed apprehension and complexity in the manner of retrieving such properties from the concerned employees of National Offices considering that their office has no direct means of monitoring the status of employment of the said personnel, particularly on the period of their retirement from service;

WHEREAS, the City General Services Office in its effort to establish a logical way of handling the matter has requested this august Body to intercede on the issue through appropriate legislative measure;



WHEREAS, in the interest of protecting the properties of the city government, this sanggunian deems it appropriate to accord preferential attention to the matter;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Sotero M. Pepito, Vice-Chairman, Committee on Police, Fire and Penology, duly seconded by City Councilor Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution REQUESTING THE CITY DIRECTOR, PHILIPPINE NATIONAL POLICE, (PNP), THE CITY JAIL WARDEN, BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP), THE CITY FIRE MARSHAL, BUREAU OF FIRE PROTECTION (BFP), AND OTHER NATIONAL OFFICES CONCERNED, TO INCLUDE IN THE SIGNATORIES OF THEIR RESPECTIVE RETIREMENT CLEARANCES, THE CITY GENERAL SERVICES OFFICER OF ORMOC CITY, AS ONE OF THE SIGNATORIES THERETO FOR THE REASON STATED HEREIN.
