RESOLUTION NO. 2009-173

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE TAMBULILID BARANGAY COUNCIL, THIS CITY, REPRESENTED BY ITS BARANGAY CAPTAIN, HON. RODRIGO SASING.

WHEREAS, the Sangguniang Panlungsod ng Ormoc has received a communication dated August 11, 2009 from the Honorable City Mayor Eric C. Codilla requesting for the passage of a resolution authorizing him to enter into and sign a Memorandum of Agreement (MOA) for and in behalf of the City Government of Ormoc with the Tambulilid Barangay Council thru its Barangay Captain, Hon. Rodrigo Sasing;

WHEREAS, the focus of the agreement is the Container Gardening Project which will be piloted at Barangay Tambulilid, this city;

WHEREAS, the City Government of Ormoc has launched the Ormoc Container Gardening Project as an alternative measure to increase family income and reduce hunger and incidence of malnutrition in depressed barangays within the City;

WHEREAS, the project aims to encourage more household to go into container gardening production and to consider the same as an alternative source of their livelihood;



WHEREAS, to make certain that the project will be effectively implemented, the city government will provide the necessary technical assistance, seedlings and organic fertilizer to all those who will participate in the project. Likewise, cash incentives will also be given to the successful growers under the aforementioned project;

WHEREAS, this sanggunian recognizes the importance and the benefits of the project to the people;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture and Fisheries, severally seconded by City Councilors Rafael C. Omega, Jr., Mariano Y. Corro and Ruben R. Capahi; be it


ADOPTED, September 3, 2009.

RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to this sanggunian for information and file;


