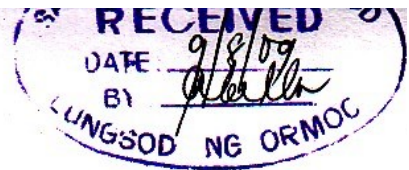

RESOLUTION NO. 2009-176

A RESOLUTION AMENDING RESOLUTION NO. 2008-211, ENTITLED
"A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ERIC C.
CODILLA TO APPLY TO THE COUNTRY DIRECTOR, GERMAN
DEVELOPMENT SERVICES (DED) FOR PARTNER SUPPORT FOR THE
PURCHASE OF AUTOCAD SOFTWARE, AND TWO (2) SETS OF
COMPUTER COSTING THREE HUNDRED EIGHT THOUSAND TWO
HUNDRED PESOS (P308,200.00) WITH 20% COUNTERPART FROM
THE CITY EQUIVALENT TO SIXTY ONE THOUSAND SIX HUNDRED
FORTY PESOS (P61,640.00).

WHEREAS, the autocad to be purchased is an upgraded software and correspondingly the computer to be purchased has also to be an upgraded unit;

WHEREAS, the total cost of the software and computer now totals to P424,200.00 which will be broken down as follows;

WHEREAS, all the amount considered, the authority given to the Hon. City Mayor as per SP Resolution No. 2008-211 shall now be amended as follows; "A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ERIC C. CODILLA TO APPLY TO THE COUNTRY DIRECTOR, GERMAN DEVELOPMENT SERVICES (DED) FOR PARTNER SUPPORT FOR THE PURCHASE OF AUTOCAD SOFTWARE, AND TWO (2) SETS OF COMPUTER COSTING FOUR HUNDRED TWENTY FOUR THOUSAND TWO HUNDRED PESOS (P424,200.00) WITH 20% COUNTERPART FROM THE CITY EQUIVALENT TO EIGHTY FOUR THOUSAND EIGHT HUNDRED FORTY PESOS (P84,840.00).

WHEREAS, the version of the autocad to be purchased is the latest and upgraded version, for this reason the amount is higher;




