RESOLUTION NO. 2009-182

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE AMENDED MEMORANDUM OF AGREEMENT (MOA) BY AND AMONG THE CITY GOVERNMENT OF ORMOC, THE DEPARTMENT OF AGRICULTURE-REGIONAL FIELD UNIT NO. 8 (DA-RFU 8) AND THE NATIONAL IRRIGATION ADMINISTRATION (NIA) FOR THE IMPLEMENTATION OF HYBRID RICE RATOONING PROJECT.

WHEREAS, the 11th Sangguniang Panlungsod ng Ormoc has passed SP Resolution No. 2009-083 dated April 23, 2009 which authorized the Honorable City Mayor Eric C. Codilla to enter into and sign the Memorandum of Agreement by and among the Department of Agriculture-Regional Field Unit No. 8 (DA-RFU 8), the National Irrigation Administration (NIA) and the City Government of Ormoc for the Implementation of Hybrid Rice Ratooning Project in Ormoc City;

WHEREAS, the City Agricultural Services Office represented by Mr. Dante E. Albarico, OIC - Crops Division, has sent a communication to the Office of the City Mayor requesting for an amendment of the "4th WHEREAS" of the agreement in view of the appeal of the farmers for continuous support until this years" second cropping season. The same communication was indorsed to this august Body for proper legislative action;

WHEREAS, the 4th WHEREAS of the Memorandum of Agreement (MOA) as approved per SP Resolution No. 2009-083 reads as follows:

"WHEREAS, 500 hectares of rice production area in Ormoc City is being targeted for the First Phase or the initial establishment of hybrid rice ratooning project during the November 2008 to April 2009 cropping season;"

WHEREAS, in view of the aforestated request of Mr. Dante E. Albarico, it is deemed necessary to amend the subject Memorandum of Agreement particularly its 4TH WHEREAS which shall now read as follows:



"WHEREAS, 500 hectares of rice production area in Ormoc City is being targeted for the First Phase or the initial establishment of hybrid rice ratooning project during the November 2008 to April 2009 and May - October 2009 cropping seasons;"

WHEREAS, all other provisions of the previous Memorandum of Agreement which were not affected by this particular amendment remains to be in force and in effect;

WHEREFORE, foregoing premises considered, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture and Fisheries, duly seconded by City Councilor Ruben R. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE AMENDED MEMORANDUM OF AGREEMENT (MOA) BY AND AMONG THE CITY GOVERNMENT OF ORMOC, THE DEPARTMENT OF AGRICULTURE-REGIONAL FIELD UNIT NO. 8 (DA-RFU 8) AND THE NATIONAL IRRIGATION ADMINISTRATION (NIA) FOR THE IMPLEMENTATION OF HYBRID RICE RATOONING PROJECT;


ADOPTED, September 16, 2009.
