A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C.  
CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF  
AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY  
GOVERNMENT OF ORMOC WITH THE VISAYAS STATE UNIVERSITY  
(VSU) FOR THE CONDUCT OF A FEASIBILITY STUDY OF  
ESTABLISHING A BAGSAKAN CENTER IN ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of 2nd Indorsement dated  
August 25, 2009 from the Office of the City Mayor requesting for the  
passage of a resolution authorizing him to enter into and sign a  
Memorandum of Agreement (MOA) with the Visayas State University (VSU) of  
the abovementioned request;

WHEREAS, the said Memorandum of Agreement mentions that the above  
parties formed a partnership to conduct a feasibility study for the  
establishment of a "Bagsakan Center" in Ormoc City referred to as the  
PROJECT;

WHEREAS, City Government of Ormoc will provide the funds needed for  
the implementation of this project to be released to Visayas State  
University (VSU) amounting to ONE HUNDRED TWENTY THREE THOUSAND SIX  
HUNDRED AND FORTY PESOS (P123,640.00) payable in accordance with the  
terms and conditions set forth in the said Memorandum of Agreement  
(MOA);

WHEREAS, Visayas State University (VSU) commits to design, promote,  
evaluate and assist in the implementation of said project consistent  
with the overall agenda of developing the local economy for countryside  
development;

WHEREAS, this august body believes that said request is reasonable,  
hence, the same be accorded due course of action;



WHEREFORE, foregoing premises considered on motion of the City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture, jointly seconded by City Councilors Mariano Y. Corro and Demosthenes F. Tugonon; be it


ADOPTED, October 01, 2009.

RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to this Sanggunian for information and file;


