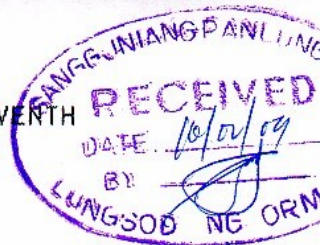

RESOLUTION NO. 2009-189

A RESOLUTION APPROVING ORDINANCE NO. 02-2009 OF THE
BARANGAY COUNCIL OF BARANGAY DOMONAR, THIS CITY,
ENTITLED: "AN ORDINANCE REGULATING THE OPERATION OF
VIDEO-KARAOKE MACHINES IN THE PRIVATE HOMES OF THE
RESIDENTS OF THIS BARANGAY AND REQUIRING A PERMIT TO
OPERATE IF THESE MACHINES ARE USED FOR COMMERCIAL
PURPOSES".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
02-2009 of the Barangay Council of Barangay Domonar, entitled: "AN
ORDINANCE REGULATING THE OPERATION OF VIDEO-KARAOKE MACHINES IN THE
PRIVATE HOMES OF THE RESIDENTS OF THIS BARANGAY AND REQUIRING A PERMIT
TO OPERATE IF THESE MACHINES ARE USED FOR COMMERCIAL PURPOSES";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City) is by law, granted the Power to
review as to whether said ordinance is consistent with law and city x x

Mariano Y. Corro and Sotero M. Pepito; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING
