RESOLUTION NO. 2009-191

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO RELEASE AND UTILIZE THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FROM THE 5% BUDGETARY RESERVE (CALAMITY FUND) AS FINANCIAL ASSISTANCE TO THE VICTIMS OF TYPHOON "ONDY" IN METRO MANILA AND OTHER AFFECTED AREAS.

WHEREAS, Typhoon "Ondoy" hit our country last September 26-27, 2009 and has gravely devastated the Metro Manila areas and other neighboring cities;

WHEREAS, the typhoon caused extreme flooding which claimed the lives of several people and caused massive destruction to properties;

WHEREAS, due to the extent of damage of Typhoon Ondoy, the Office of the President has declared the aforementioned areas affected under the State of Calamity;

WHEREAS, the Implementing Rules and Regulations of R.A. 8185 particularly Sec. 6, Par. B) on the Usage of the 5% Calamity fund states that:

b.2 A portion of the Calamity Fund may also be authorized to be used by the LGU concerned to provide financial assistance to other LGUs whose area or portion thereof had been declared under state of calamity by its Sanggunian;

WHEREAS, the City Government of Ormoc, mindful of the plight of the residents in the affected areas, sympathize with them in their time of need and likewise, would like to extend financial support for the victims;
