AL SPECIFICALLY DESCRIBED AS CADASTRAL LOT NO. 2335,
COVERED BY TCT NO. 45888 LOCATED AT BARANGAY PUNTA,
THIS CITY.

WHEREAS, the Eleventh Sangguniang Panlungsod ng Ormoc has received
an indorsement dated August 3, 2009 from the Office of the City Mayor
requesting that the Honorable Mayor be granted authority to purchase a
plot owned by Mamerto R. Bade, et al, known as Lot No. 2335 of the
Cadastral Survey of Ormoc City which is situated at Barangay Punta;

WHEREAS, the subject lot to be purchased was affected by the
Rehabilitation/construction of Drainage System Project of the city;

WHEREAS, the City Appraisal Committee through their Resolution No.
2009-03, has determined and appraised the property at P2,500.00 per
square meter which amount was considered as fair, just and reasonable
appraised value;

WHEREAS, in consideration that the aforementioned lot has been used
by the city government in its development project it is deemed
appropriate to compensate the owners with the fair value of such
property;
