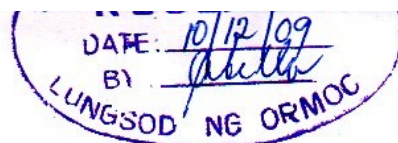

RESOLUTION NO. 2009-196

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF HEALTH.

WHEREAS, this Sanggunian is in receipt of 2nd Indorsement dated August 26, 2009 from the Office of the City Mayor requesting for the passage of a resolution authorizing him to enter into and sign a Memorandum of Agreement (MOA) with the Department of Health;

WHEREAS, as cited in the Memorandum of Agreement partnership were forged between the DOH and individual provinces/cities to undertake the City-Wide Investment Plan for Health (CIPH), a local health development program and medium term public investment plan consistent with FOURmula One (F1) for health, which embodies and integrated and comprehensive approach to achieve health sector goals, like Millennium development Goals (MDGs) and the national Objective for Health (NOH), in devolved health system within specified technical standards;

WHEREAS, the agreement stipulates that the City Government of Ormoc agreed to fund and implement the programs, projects and activities under the enhanced CIPH through their own financing sources and available development partners that are coordinated by the DOH through SDAH;

WHEREAS, the august Body finds the Memorandum of Agreement (MOA) beneficial to the people, hence, the same be accorded due course of action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of the City Councilor Rafael C. Omega, Jr., Chairman, Committee on Health, jointly seconded by City Councilors Sotero M. Pepito and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF HEALTH;
