A RESOLUTION APPROVING BAC RESOLUTION NO. 2009-323,  
ENTITLED: "A RESOLUTION RECOMMENDING THAT THE  
ADDITIONAL WORKS/ACTIVITIES (ADDITIONAL TWO CLASSROOM)  
FOR THE ON-GOING PROJECT, CONSTRUCTION OF TWO (2)  
CLASSROOM SCHOOL BUILDING AT TAMBULILID ELEMENTARY  
SCHOOL, BRGY. TAMBULILID, ORMOC CITY BE UNDERTAKEN  
THROUGH A NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR,  
L.M. BALTONADO CONSTRUCTION IN THE AMOUNT OF ONE  
MILLION SEVENTY SEVEN THOUSAND SIX HUNDRED FORTY &  
16/100 (P1,077,640.16) PESOS ONLY" AND FURTHER  
AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO  
SIGN THE SAID NEGOTIATED CONTRACT FOR AND IN BEHALF OF  
THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this sanggunian has received an indorsement dated September 29, 2009 from City Administrator Dennis Y. Capuyan in his capacity as Chairman of the Bids and Awards Committee (BAC) in connection with the aforementioned BAC Resolution No. 2009-323 and further recommending that the Honorable City Mayor Eric C. Codilla be authorized to sign the said Negotiated Contract for and in behalf of the City Government of Ormoc;

WHEREAS, the Schools Division Superintendent, Vicenta C. Alibangbang through a communication dated August 20, 2009 has recommended that the said project be undertaken through Negotiated Contract under the same contractor, L.M. Baltonado Construction, in view of the exemplary contracting capacity and satisfactory performance shown by the said contractor;

WHEREAS, the OIC-City Engineer Ranulfo D. Oliveros, also made a justification in resorting to a Negotiated Contract for the Construction of additional two (2) classrooms at Tambulilid Elementary School citing therein the nature of contiguity of the project to the original contract in which case there are similar or related Scopes of Work. Furthermore, it was found out that the contractor, L.M. Baltonado Construction did not incur negative slippage in the original undertaking and was proven to have the capacity to perform technically, legally, and financially the subject contract using the same unit prices as in the original contract;

WHEREAS, the City Treasurer has issued a Certificate of Availability of Fund dated August 27, 2009 certifying therein that the amount needed for the project is available to be taken from the CY 2009 SEF Supplemental Budget No. 01 as approved per LSB Appropriation Ordinance NO. 2009-02;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriations, severally seconded by City Councilors Claudio P. Larrazabal, Rafael C. Omega, Jr., and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING BAC RESOLUTION NO. 2009-323, ENTITLED: "A RESOLUTION RECOMMENDING THAT THE ADDITIONAL WORKS/ACTIVITIES (ADDITIONAL TWO CLASSROOM) FOR THE ONGOING PROJECT, CONSTRUCTION OF TWO (2) CLASSROOM SCHOOL BUILDING AT TAMBULILID ELEMENTARY SCHOOL, BRGY. TAMBULILID, ORMOC CITY BE UNDERTAKEN THROUGH A NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR, L.M. BALTONADO CONSTRUCTION IN THE AMOUNT OF ONE MILLION SEVENTY SEVEN THOUSAND SIX HUNDRED FORTY & 16/100 (P1,077,640.16) PESOS ONLY" AND FURTHER AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE SAID NEGOTIATED CONTRACT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC;
