A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) BY AND AMONG THE WORLD VISION DEVELOPMENT FOUNDATION, INC., DEPARTMENT OF HEALTH (DOH) - CENTER FOR HEALTH DEVELOPMENT REGIONAL 8, AND THE CITY GOVERNMENT OF ORMOC FOR THE IMPLEMENTATION OF THE SOCIAL MOBILIZATION ON TUBERCULOSIS (SMT).

WHEREAS, this Sanggunian is in receipt of 2nd Indorsement dated 14 October 2009 from the Office of the City Mayor relative to the indorsement from Dr. Nelita D. Navales, City Health Officer II, requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into and sign a Memorandum of Agreement (MOA) by and among World Vision Development Foundation, Inc., Department of Health (DOH) - Center for Health Development Region 8 and the City Government of Ormoc;

WHEREAS, World Vision is currently implementing a health program which aims to empower communities to manage and sustain community based activities that will increase TB symptomatic consultation to health facilities, and patient's compliance to treatment thus improving case detection and cure rate in line with the DOH benchmarks;

WHEREAS, the DOH, through its Infectious Disease Office (IDO) and its Regional Health Offices will provide technical assistance and participate in program planning, monitoring and evaluation;

WHEREAS, the City Government of Ormoc considers development projects as an important and valued undertaking to ensure the progress of the locality and its people and recognizes the need for an integrated and multi-sectoral partnership to ensure the pooling of financial and technical resources for well coordinated development endeavors;

WHEREAS, the august body finds the Memorandum of Agreement (MOA) beneficial to the people, hence, the same be accorded due course of action;

WHEREFORE, FOREGOING PREMISES, CONSIDERED, on motion of the City Councilor Rafael C. Omega, Jr., Chairman, Committee on Health, jointly seconded by City Councilors Mariano Y. Corro and Sotero M. Pepito; be it
