A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE RENEWAL OF THE MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC THRU THE ORMOC CITY HEALTH DEPARTMENT AND SAN LORENZO RUIZ COLLEGE OF ORMOC.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement date 13 October, 2009 from the Office of the City Mayor of Ormoc, requesting authority to enter into and sign the renewal of the Memorandum of Agreement (MOA) for and in behalf of the City Government of Ormoc thru Ormoc City Health Department and San Lorenzo Ruiz College of Ormoc;

WHEREAS, as cited in the said memorandum of agreement the City Health Department is a government agency mandated to promote, protect, preserve or restore the health of the people through the provision and delivery of health services and through the regulation and encouragement of providers of health goods and services;

WHEREAS, the San Lorenzo Ruiz College of Ormoc, Inc., is also mandated to render community based work in health-related services, as practicum and application of the student's academic and theoretical knowledge, as such instituted the Community Extension Services (CES) unit of the school, in the integration and coordination of all community-based projects;

WHEREAS, the agreement also stipulates the specific obligation of both parties, under the terms and conditions agreed upon;

WHEREAS, this august Body believes that the terms and conditions of the Memorandum of Agreement are beneficial and reasonable, hence, the same shall be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Health, duly seconded by City Councilor Sotero M. Pepito; be it
