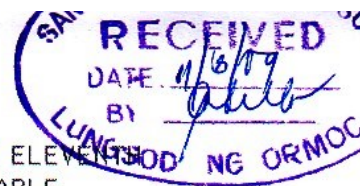

RESOLUTION NO. 2009-208

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BY AND AMONG THE CITY GOVERNMENT OF ORMOC, THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, MINES AND GEOSCIENCES BUREAU (DENR-MGB) - REGION VIII, AND THE OFFICE OF THE CIVIL DEFENSE (OCD) - REGION VIII FOR THE INSTALLATION AND MAINTENANCE OF LANDSLIDE WARNING SIGNAGES IN ORMOC CITY.

WHEREAS, the 11th Sangguniang Panlungsod ng Ormoc has received an indorsement dated October 22, 2009 from the Honorable City Mayor Eric C. Codilla requesting for authority to enter into and sign the Memorandum of Agreement (MOA) by and among the City Government of Ormoc, the Department of Environment and Natural Resources, Mines and Geosciences Bureau, Region VIII, and the Office of Civil Defense (OCD) - Region VIII for the installation and maintenance of landslide warning signages in the City of Ormoc;

WHEREAS, the matter is a joint undertaking of the aforementioned parties under the Hazards Mapping and Assessment for Effective Community - Based Disaster Risk Management (READY) Project and bind themselves to collaborate their efforts in order to help manage and mitigate landslide disasters within Ormoc City;

WHEREAS, the installation of landslide warning signages in the city particularly in areas identified as "landslide prone hazardous areas" is deemed very important and necessary under the community-based disaster preparedness management measures;

WHEREAS, considering that the signing of the MOA and the ceremonial unveiling of the installed signages is proposed to be done on the 29th of October, 2009, it is appropriate that the matter be accorded urgent action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources, severally seconded by City Councilors Rafael C. Omega, Jr., Mariano Y. Corro and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to this sanggunian for information and file;


