WHEREAS, the 11th Sangguniang Panlungsod ng Ormoc has received an indorsement dated October 22, 2009 from the Honorable City Mayor Eric C. Codilla requesting for authority to enter into and sign the Memorandum of Agreement (MOA) by and among the City Government of Ormoc, the Department of Environment and Natural Resources, Mines and Geosciences Bureau, Region VIII, and the Office of Civil Defense (OCD) - Region VIII for the installation and maintenance of landslide warning signages in the City of Ormoc;
