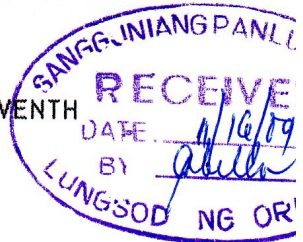

RESOLUTION NO. 2009-215

A RESOLUTION APPROVING ORDINANCE NO. 05-S-2009 OF THE BARANGAY COUNCIL OF BARANGAY SUMANGGA, THIS CITY, ENTITLED, "AN ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES AND OTHER CERTIFICATES, PERMITS, AND OTHER CHARGES".

WHEREAS, this sanggunian is in receipt of Barangay Ordinance No. 05-s-2009 of the Barangay Council of Barangay Sumangga, entitled: "AN ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES AND OTHER CERTIFICATES, PERMITS, AND OTHER CHARGES";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforesaid ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to review as to whether said ordinance is consistent with law and city xxx ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the said ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Sumangga to legislate;
