A RESOLUTION APPROVING ORDINANCE NO. 06 S. 2009 OF THE BARANGAY COUNCIL OF BARANGAY SUMANGGA, THIS CITY, ENTITLED: "AN ORDINANCE REGULATING THE SALE OF LARGE CATTLE, (LIKE CARABAOS, COWS AND HORSES), WITHIN THE JURISDICTION OF THIS BARANGAY AND IMPOSING PENALTIES IN VIOLATION THEREOF".

WHEREAS, this sanggunian is in receipt of Barangay Ordinance No. 06 s. 2009 of the Barangay Council of Barangay Sumangga, entitled: "AN ORDINANCE REGULATING THE SALE OF LARGE CATTLE, (LIKE CARABAOS, COWS AND HORSES), WITHIN THE JURISDICTION OF THIS BARANGAY AND IMPOSING PENALTIES IN VIOLATION THEREOF";
