RESOLUTION NO. 2009-217

A RESOLUTION APPROVING BAC RESOLUTION NO. 2009-380,
ENTITLED: "A RESOLUTION RECOMMENDING THAT THE
ADDITIONAL SCOPE OF WORKS FOR THE CONSTRUCTION OF NEW
ORMOC CITY HALL BUILDING (PHASE V) AT GOVERNMENT
CENTER, AUNUBING STREET, ORMOC CITY, BE UNDERTAKEN
THROUGH A NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR,
PHILIPPINE RIGID CONSTRUCTION CORPORATION IN THE AMOUNT
OF EIGHTEEN MILLION TWO HUNDRED FORTY SIX THOUSAND SIX
HUNDRED TWENTY ONE AND 83/100 (P18,246,621.83) PESOS
ONLY" AND FURTHER AUTHORIZING THE HONORABLE CITY MAYOR
ERIC C. CODILLA TO SIGN THE SAID NEGOTIATED CONTRACT
FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC.

WHEREAS, the Eleventh Sangguniang Panlungsod ng Ormoc has received an urgent indorsement dated November 4, 2009 from the Office of the City Mayor relative to the aforementioned BAC Resolution No. 2009-380 and further requesting that the Honorable City Mayor Eric C. Codilla be granted authority to sign the said Negotiated Contract for and in behalf of the City Government of Ormoc;

WHEREAS, the city's Technical Working Committee (TWC) headed by Engr. Raoul E. Cam, City Planning and Development Coordinator, through a communication dated October 28, 2009 has recommended that the additional scope of works (as enumerated in same letter) in connection with the ongoing Construction of New Ormoc City Hall Building and Local Area Networking (LAN) Structural Cabling Project be undertaken through a Negotiated Contract with the same contractor, Philippine Rigid Construction Corporation, using the same unit cost involved in the original contract;

WHEREAS, the Philippine Rigid Construction Corporation has been proven to possess exemplary contracting capacity and has shown satisfactory performance in the execution of the original contract. Hence, the members of the TWG believe that it can perform the additional works to be done without further problems;

WHEREAS, the City Treasurer has issued a Certificate of Availability of Funds dated November 3, 2009 certifying therein that funds are available to cover the said project to be taken from the CY 2009 Supplemental Budget No. 01 as approved by this Sanggunian per Appropriation Ordinance No. 2009-002;

WHEREAS, in order to expedite the completion of the project which is considered as one of the priorities of the city, it is deemed necessary to accord preferential attention to the matter;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriations, jointly seconded by City Councilors Mariano Y. Corro and Sotero M. Pepito; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING BAC RESOLUTION NO. 2009-380, ENTITLED: "A RESOLUTION RECOMMENDING THAT THE ADDITIONAL SCOPE OF WORKS FOR THE CONSTRUCTION OF NEW ORMOC CITY HALL BUILDING (PHASE V) AT GOVERNMENT CENTER, AUNUBING STREET, ORMOC CITY, BE UNDERTAKEN THROUGH A NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR, PHILIPPINE RIGID CONSTRUCTION CORPORATION IN THE AMOUNT OF EIGHTEEN MILLION TWO HUNDRED FORTY SIX THOUSAND SIX HUNDRED TWENTY ONE AND 83/100 (P18,246,621.83) PESOS ONLY" AND FURTHER AUTHORIZING THE HONORABLE CITY MAYOR ERIC C.
